FSDP logo approved artwork

FSDP logo – two colour version

This version of the FSDP logo should be used whenever possible, where possible on a white background.

FSDP logo – black version

This version of the FSDP logo should only be used when reproduction in two colours is not possible.

FSDP logo – reverse version

Use the reversed version of the logo on dark coloured backgrounds or on images offering sufficient contrast.

Do not modify the logo artwork in any way...



Do not alter the colour way



Do not alter proportions



Do not rearrange elements



Do not use logotype alone



FSDP logo minimum space

Do not allow other design elements to intrude upon the FSDP logo. Always maintain a minimum clear space equivalent to the height of the 'F' character at any given size.



FSDP logo minimum size

The FSDP logo can be reproduced down 15mm across the width of the type element. Note that the means of reproduction will inevitably affect quality of reproduction at small sizes.
